COURSES & BIRDS

All stakes are single course without bird field.

Released and native Bobwhite Quail in all stakes except puppy stakes.

Open Limited Gun Dog and Amateur Limited Gun Dog are retrieving stakes.

Retrieves will be shoot-on-course with first bird shot for retrieve.

A blank cartridge may be fired in puppy stakes at the discretion of the handler.

Standard AKC rosettes awarded to all placed dogs.

Helen Seelye Cup Traveling Trophy awarded to winner of Open Limited Gun Dog.

DIRECTIONS

From North US 17 / US 301: From the intersection of US 17 and US 301 at Port Royal, Virginia, follow US 17 South approximately 19 miles to State Road 624 at Caret (Old Courthouse Road). Turn left onto State Road 624 (Old Courthouse Road) and travel approximately ½ mile to entrance for field trial grounds on left.

From Richmond, VA and the South: Take US 360 East to Tappahannock, Virginia. Merge onto US 17 North at Tappahannock. At traffic light where US 360 turns right toward Warsaw, stay straight on US 17 North and go approximately 6 miles to State Road 624 (Old Courthouse Road). Turn right on State Road 624 (Old Courthouse Road) and go approximately ¼ mile to entrance to field trial grounds on right.

NOTE: Do not attempt to enter the plantation via Beverly Lane off of US-17. You will encounter a locked gate and there is no turn-around.
