Open Limited Gun Dog and Amateur Limited Gun Dog are retrieving stakes.

Retrieves will be shoot-on-course with first bird shot for retrieve.

No firing in puppy stake.

From US-15 (North or South): Turn North on Hwy 20 out of Dillwyn. Turn left on 649, Slate River Mill Rd. Pass 658, St. Andrews Church Rd, then go 1 mile and look for wooden fence on left and entrance gate.

From Charlottesville: Take Hwy 20 South through Scottsville. Cross Slate River Bridge. Turn right on 649, Slate River Mill Rd. Pass 658, St. Andrews Church Rd, then go 1 mile and look for wooden fence on left and entrance gate.

From Richmond: Take US-60 West past intersection with US-15 through Buckingham Court House. Cross Slate River, then turn right on 648, Hall Rd. At stop sign, turn right on 649, Slate River Mill Rd. Go ½ mile, passing first entrance to Slate River Farm to next entrance on right.
