Dogs which first qualify at this trial will not be permitted to enter limited stakes. Horseback handling will not be permitted. No motorized vehicles allowed on course other than those designated for gunners, bird planter, dog wagon or handlers with written AKC accommodation.

**COURSES & BIRDS**

All stakes will be walking on a single course without a bird field. Retrieving stakes will be done at judges' discretion with callbacks for retrieve. Bobwhite Quail will be released in all stakes except puppy stakes, native game birds and "preserve pheasant" may be present in all stakes. Open Limited Gun Dog and Amateur Gun Dog are retrieving stakes. No blank firing in puppy stake.
