**COURSES & BIRDS**

All stakes will be walking on a single course without a bird field. Retrieving stakes will be done at judge's discretion with callbacks for retrieve. Bobwhite Quail will be released in all stakes except puppy stakes, native game may be present in all stakes. Open Gun Dog and Amateur Limited Gun Dog are retrieving stakes. No blank firing in puppy stake.
